



FOSTER AGREEMENT

This agreement is made this _____ day of _____, 20____ by and between _____ (hereinafter called "Foster") and Army's Legacy Animal Rescue and Sanctuary, Inc. (hereinafter called "Army's Legacy"). Foster acknowledges that he or she is not becoming the owner of any of said animals, but is only willing to provide humane care for any such animal until a permanent home is found.

It is agreed between Army's Legacy and Foster as follows:

1. Army's Legacy delivers to Foster and Foster hereby accepts from Army's Legacy a certain animal described below, and Foster agrees to humanely take care of said animal until Army's Legacy is able to place the animal in a proper permanent home. Foster will immediately, peaceably and voluntarily deliver said animal to Army's Legacy upon request, and will make no claim of ownership, title, right or interest in and to said animal.

2. Foster agrees to let Army's Legacy inspect Foster's premises where the animal is being kept at any time to ascertain and satisfy itself that the animal is well cared for. Foster agrees to keep a collar and identification tag on the animal at all times.
3. Foster agrees to bring the animal to adoption events when requested by Army's Legacy.
4. Foster agrees not to alter in any way the appearance of the animal being fostered without written permission of Army's Legacy. This includes declawing and cropping of ears or tails.
5. Foster agrees to provide adequate food, water, shelter, and kind treatment for said animal at all times. In addition, Foster must adhere to all state and local animal laws. Foster agrees to follow all additional written instructions from Army's Legacy.
6. Foster agrees to notify Army's Legacy as to any behavioral or health problems of the animal. Army's Legacy reserves the exclusive right to determine the proper course of action to take upon such notification. The cost of any medical care will be covered by Army's Legacy.

7. Foster will notify Army's Legacy in the event any change occurs in the address or telephone number listed below. Foster understands and acknowledges that he/she does not have any right or authority to keep the foster animal or place foster animal in other homes or place with other individuals unless permission is given in writing by Army's Legacy.
8. Foster is undertaking these obligations with no claim, now or in the future, to any type of compensation or reimbursement for caring for said animal, except that Army's Legacy will be responsible for providing food and supplies while the animal is in the Foster's care.
9. Foster agrees that accidental animal bites or other injuries to humans and other animals do occur, and agrees to hold harmless and indemnify, and protect Army's Legacy from any claim or suit filed by anyone as a result of such an incident. In addition, Army's Legacy will not be responsible if animal should damage or destroy property belonging to Foster, or shall transfer any disease or internal or external parasites to other animals belonging to Foster.
10. If Foster wishes to adopt said animal, Foster must go through Army's Legacy adoption program screening process. Army's Legacy reserves the right to determine final disposition of the animal.
11. This Agreement is the entire agreement of the parties, and there are no oral promises or representations made in addition to this contract, and it may only be changed in writing signed by both Army's Legacy and Foster.
